## Developmental Disability Waiver

- Medicaid Home and Community Based Service program for individuals with Intellectual and Developmental Disabilities
- Section 2176 of the Omnibus Budget Reconciliation Act of 1981 authorized section 1915(c) of the Social Security Act



# Eligibility - ID

- Significant subaverage intellectual functioning existing concurrently with deficits in adaptive behaviors
- Onset prior to age 18

# Eligibility — SRC

- Qualifying medical diagnosis listed in the New Mexico Administrative Code at 8.290.400.10 NMAC.
- Manifested prior to age 22; and
- Results in impairment of general intellectual functioning or adaptive behavior similar to that of an individual with intellectual disability; and
- Lifelong and indefinite; and
- Results in at least 3 substantial functional limitations in one of the following areas of major life activity:
  - 1. self-care
  - 2. expressive and receptive language
  - 3. learning
  - 4. mobility
  - 5. self-direction
  - 6. capacity for independent living
  - 7. economic self-sufficiency

## Qualifying Medical Condition

- Seizure Disorder
- Cerebral Palsy
- Trisomy 21
- Klinefelter (XXY Syndrome)
- Prader-Willi Syndrome
- Autistic Disorder per DSM-IV guidelines
- Lissencephaly
- Primary Microcephaly
- Hydrocephalus
- Continued in NMAC, as there are many

### Substantial Functional Limitations

- Adaptive behavior scores ≠ substantial functional limitation
- Review all records such as diagnostics, school records, medical charting, etc.
- Current is best!

### Getting Started - Registration

- Complete MAD 325 over the phone, in person, by fax
- Return the application packet
- Submit any documentation that may assist us in making a determination
  - 1. IEPs
  - 2. REEDs
  - 3. Medical records
  - 4. Neuropsychological/psychological evaluations
  - 5. Other diagnostics
  - 6. Etc.
