New Mexico Home Visiting Program Framework

Vision:

New Mexico families are supported to raise children who are healthy, happy and successful.

Level II Project Overview

Level II/Targeted Home Visiting is designed for families who need enhanced home visiting services that will aid in prevention adverse childhood experiences (ACEs).

Services in Level II are more targeted to ensuring the families have access to resources that will help decrease the increased stress that the caregiver might be facing that is impacting the parent/child relationship.

Level II is focused to be served in Early Childhood Investments Zones and communities at risk due to a variety of experiences that the caregiver and child may be exposed to that lead to a negative impact on the relationship.

The Vision/Purpose of the Pilot Project

The goal of the pilot phase of Level II is for programs to work in a cohesive partnership with CYFD to develop the standards and practices that will address the families needs across the state and in different communities.

Programs will identify and report to CYFD what are the specific and unique needs when it comes to supports with consultation, data and management/monitoring of their programs for them to be successful in supporting Level II families. Programs will also be instrumental in providing feedback on current standards for Level II. This will influence future implementation of Level II programs for other providers in the state.

Definition of Level II

New Mexico Home Visiting Program Standards (October 2016)

"Level II Targeted Interventions Home Visiting Program provides services to families that are referred or identified during participation in the Home Visiting program in general to be at risk and/or in need of a higher level of intervention." (pg. 5)
