# i. INTRODUCTION

# A. PURPOSE OF THIS REQUEST FOR PROPOSALS

Region 9 Education Cooperative (REC 9) on behalf of the New Mexico Public Education Department (NMPED) is soliciting proposals to establish a contract through competitive negotiations for the procurement of qualified grantees to deliver a high-quality State-Funded Out-of-School Time Program that will serve students attending high poverty and low performing schools throughout the State of New Mexico.

- 1. State-Funded Out-of-School Time Program will provide students a broad range of exceptional school-linked learning and developmental opportunities designed to reinforce topics introduced during the students' traditional learning day.
- 2. State-Funded Out-of-School Time Program programming should be provided during non-school hours or periods when school is not in session, such as before and after school, holidays, weekends, or summer recess.
- 3. Diverse stakeholders within each community should be involved in the planning and delivery of the services. It is an expectation that grantees will design program activities based on teacher, parent, and student input and include volunteers to assist in program delivery. All State-Funded Out-of-School Time Program team members (volunteers, employees, subcontractors, etc.) must all pass an FBI background check prior to working directly with students, in accordance with 22-14-32 NMSA 1978.

Are State-Funded Out-of-School Time Program considered childcare?These programs are not childcare programs. Rather, they are out-of-school-time learning opportunities that exist to help close the opportunity and achievement gap for students in New Mexico. This is no childcare; these are additional educational hours that will impact student if utilized correctly, through implementation of curriculum designed to positively impact the trajectory of students attending the program, prov opportunities in which underserved students might not otherwise engaged		

The New Mexico Public Education Department (NMPED) will use this application to guide the program/budget review. This application is available for a year grant in the amount of up to **\$1,000.00 per student**. This Grant can be submitted for multiple schools within the same district. The grant will address the disproportionate impact of geographically and historically underserved individual student groups (including students from low-income families, children with disabilities, English Language Learners, racial or ethnic minorities, students experiencing homelessness, children and youth in foster care, and migratory students during out-of-school time). When answering all grant questions, the applicant should have these sub-groups in mind.

The scope of this procurement is to select qualified grantees to deliver high-quality State-Funded Out-of-School Time Program that will work to meet the New Mexico State-Funded Out-of-School Time Program selected statewide student outcomes and performance measures at each community learning center. The program will also provide services for students including, but not limited to academic enrichment opportunities, small group tutoring, homework assistance and hands-on projects for STEM, art and nutrition, drug, and violence prevention.

# **Evidenced Based Practices**

Here are the four tiers of evidence-based practices in ESSA

STRONG. Strong studies show positive and meaningful ("statically significant") results with randomized control trials (RCT). RCTs are viewed as the gold standard of evaluation because they are the best way to determine the effectiveness of a program or policy. RCTs take a large group of people and randomly assign them to the intervention being evaluated (the "treatment" group, in this case, is an afterschool program) or assign them to have no intervention (also known as the "control group"). However, the level of resources (time, money, expertise, etc.) necessary for RCT studies makes them incredibly difficult to implement and limits their availability. This is why it's important that the law also includes the following tiers of evidence.

MODERATE. A moderate study will demonstrate a meaningful positive result on student outcomes based on a quasi-experimental study—a study that, like RCTs, has a "control" group and a "treatment" group, but unlike RCTs, it does not include the random assignment to a group.

PROMISING. A promising study—or correlational study—is one that shows a relationship between an activity or program and student improvements, but it does not prove that the specific activity or program

under study was the cause of the change. For example, a correlational study may find that there is a relationship between gains in students' communication skills and their participation in an afterschool program, but it would not be able to say for certain that participating in the afterschool program caused students to improve their communication skills.

UNDER EVALUATION. In this final, fourth tier of evidence, the law recognizes that the evidence base is itself a work in progress. The "under evaluation" designation exists for activities and programs that, while yet untested, are rationally derived from research and will be tracked to see what effects they have.



Partnership
The responsible entity assures that formal agreements with the schools the students attend and community partners, reflect that the planning and implementation of the community learning center(s) was and will be carried out in active collaboration.
Program Leadership
The responsible entity will maintain active Program Launch Documents, inclusive of Communication and Safety Plans, approved by the PED as well as team member background check records and subcontractor assurance forms.
The responsible entity will maintain active Program Logistic Documents, inclusive of Transportation Plan(s) and compliant Meal/Snack Plan(s), approved by the PED.
The responsible entity will maintain active Continuous Quality Improvement (CQI) Documents, inclusive of bi-annual surveys, Spring Action Plan(s), and a Continuation Proposal (or End of Year Summary during the fifth year of the funding cycle) approved by the PED.
Capacity Building
The responsible entity assures that at least two professional development sessions will be facilitated or coordinated by the grantee each year, one per semester at minimum, and the materials used during those trainings will be uploaded into the approved State data software program.
The responsible entity assures the State Funded Out of School Time Director, individual center coordinators, and direct instructors will participate in at least one professional development session each semester.

The responsible entity will keep and provide accurate, fiscal information, as may be required for fiscal audit and comply with the all PED Request for Reimbursement criteria.

5. Conditions of Employee Payment
The responsible entity assures that employees paid by State Funded Out of School Time funds will engage in the specific goals set forth in the proposal, and payment using State Funded Out of School Time funds will be based on the full or proportionate salary and time worked.
6. Conditions of Fund Expenditures
The responsible entity assures that funds will be expended according to the purpose and intent for which they were designated, meeting both State and Federal rules and regulations.
7. Required Annual Training
The responsible entity assures that at least one the grantee's fiscal representatives will attend a PED annual fiscal training.
8. Monthly RFR and Reporting Requirements
The responsible entity assures that each month, the grantee will submit a Request for Reimbursement (RFR) and provide fiscal documentation, as required by the PED, with software purchased by the funded partner that includes a <i>systems generated report</i> with each request for reimbursement submitted to PED that illustrates:
1. Time/date of system-generated report
2. Period of reporting (from/to)

9. Monthly Fiscal Documentation Submission

Continued Funding

	The responsible entity will purchase and utilize PED identified software, designed to allow compliance with the Federal data system, by submitting the required data in a timely manner as identified by the PED.	
	The responsible entity will participate in the Continuous Quality Improvement (CQI) processes annually, as identified by the PED. This includes biannual surveys, the Spring Action Plan(s), and an end-of-year report/Continuation Proposal.	
	The responsible entity will participate in the New Mexico State Funded Out of School Time Comprehensive Evaluation Process, meeting requirements for data and reporting as identified by the PED.

# C. PROCUREMENT AND CONTRACT CONTACT

This RFP will result in multiple awards. This procurement may be used by other parties. The contract may be implemented for a term of one (1) year, and may be extended on an annual basis for up to three (3) years in one-year increments for a total of four (4) years, contingent upon sufficient funding and satisfactory work performance provided by the selected vendor.

In no case will the contract, including all renewals thereof, exceed a total of four (4) years in duration, as set forth in NMSA 1978, § 13-1-150. A contract awarded as a result of this RFP is contingent upon appropriation by the New Mexico Legislature or other funding sources for the period of this procurement, satisfactory contract compliance, and the Contractor's ability to successfully provide services. Should contract non-compliance be determined, the contract may be terminated or amended. A potential offeror or the offeror agrees to comply with state laws and rules pertaining to workers' compensation insurance coverage for its employees. If the offeror fails to comply with the Workers' Compensation Act and applicable rules when required to do so, the contract may be canceled effective immediately.

# D. DEFINITION OF TERMINOLOGY

This section contains definitions that are used throughout this procurement document, including appropriate abbreviations.

- 1. "Agency" is the issuing agency of procurement, contracts, purchase orders and all aspects associated with contract/procurement management. Agency shall be used, unless otherwise written specifically identifying the entity.
- 2. "**Annual assessment**" means an annual, meaningful, and collaborative inquiry conducted by the community school coordinator and informed by the site-based leadership team on the progress of the programs and services within the community school

- 3. "Asset mapping" means an assessment of the community, including organizations, people, partnerships, facilities, funding, and policies. An asset assessment provides information about the strengths and resources of a community.
- 4. "Award" means the final execution of the contract document.
- 5. "**Braiding Funds**" means combining two or more sources (or streams) of funding to support a program or activity. Braided funding pools multiple funding streams toward one purpose, while separately tracking and reporting on each source of funding.
- 6. "**Center**" means one location providing State-Funded Out-of-School Time Program Services. This could be a school campus or the location of a community-based or faith-based organization.
- 7. "CLC" means Community Learning Center. State-Funded Out-of-School Time Program(State-Funded Out-of-School Time Program) is a common acronym for this grant program.
- 8. **"Close of Business"** means 5:00 PM Mountain Standard or Mountain Daylight Time, whichever is in effect on the date given.
- 9. "Coalition for community schools" means a statewide coalition of community schools, members of their site-based leadership teams, foundations, businesses, and other organizations, including unions, cultural and linguistic experts, and tribal leaders, who have joined together to advocate for and support the development of community schools across New Mexico, in alignment with an evidence-based community school framework.
- 10. "Community-based learning (CBL)" means a model that grounds student learning in civic engagement and addresses real-world, community issues. CBL is interdisciplinary in nature and deepens the purposeful connection between neighborhoods and schools. The goal of a community-based curriculum is to strengthen and galvanize the assets of families, school educators, and local community members to work collaboratively to enrich and expand student learning. The curriculum centers on local institutions, history, knowledge, language, literature, culture, and environments and aligns with scientific discoveries about how sociocultural factors and the structure of learning environments influence learning.
- 11. "**Community-based organization (CBO)**" means a public or private nonprofit organization of demonstrated effectiveness that is representative of a community or significant segments of a community and provides educational or related services to individuals in the community.

- 12. "**Community school**" means a public school that partners with families and the community—including tribal partners, nonprofit community-based organizations, and local businesses—to provide well-rounded, educational opportunities and supports for student success through the implementation of a community school framework.
- 13. "**Community school coordinator**" means a full-time person employed by the lead partner agency who works within a community school as part of the site-based leadership team.
- 14. "**Community school director or manager**" means a person who oversees three or more community schools and coordinates implementation of the community schools framework across all community school sites.
- 15. "**Community school framework**" means a set of strategies implemented in a community school that include culturally and linguistically responsive instruction, programs, services, and restorative practices that focus on building and maintaining relationships. The community school framework is the method by which to meet the community school initiative.
- 16. "**Community school initiative**" means a implementation of the community school framework to provide comprehensive or targeted and improvement activities, pursuant to the federal Every Student Succeeds Act (ESSA).
- 17. "**Community school plan**" means a written plan that describes how the four pillars of community schools will be addressed; how each eligible school will provide culturally and linguistically relevant communication between schools and families; how the eligible schools will leverage private, local, State, and Federal funds; and how the eligible schools will establish and maintain partnerships with nonprofit organizations, community-based organizations, institutions of higher education, health-care providers, businesses, and other community organizations.
- 18. "**Community-wide leadership team**" means a team that includes the site-based leadership team, families, community partners, tribal partners, nonprofit organizations, and unions and that guides collaborative planning, site-based budgeting, and implementation of the community school framework.
- 19. "**Comprehensive support and improvement (CSI)**" means a school identified as needing intervention under ESSA, including the lowest-performing five percent of Title I schools, schools with a high school graduation rate of less than 67 percent for two out of the last three years, and schools with chronically low-performing ESSA subgroups of students.

- 20. "**Confidential**" means confidential financial information concerning Offeror's organization and data that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act §§57-3-A-1 through 57-3A-7, NMSA 1978,. See also NMAC 1.4.1.45. The following items may **not** be labeled as confidential: Offeror's submitted Cost response, Staff/Personnel Resumes/Bios (excluding personal information such as personal telephone numbers and/or home addresses), and other submitted data that is **not** confidential financial information or that qualifies under the Uniform Trade Secrets Act.
- 21. "**Consortium of schools**" means a group of public schools or Bureau of Education (BIE) schools across school districts or within a regional education cooperative.
- 22. **"Contract"** means any agreement for the procurement of items of tangible personal property, services or construction.
- 23. **"Contract Manager"** means the individual selected by the Agency to monitor and manage all aspects of the contract resulting from this RFP.
- 24. "Contractor" means any business having a contract with a state agency or local public body.
- 25. "CQI" means the Continuous Quality Improvement cycle.
- 26. "**Culturally and linguistically responsive**" means validating and affirming an individual's home culture and language to create connections with other cultures and languages in various social contexts.
- 27. **"Deliverable"** means any measurable, tangible, verifiable outcome, result, or item that must be produced to complete a project or part of a project.
- 28. **"Department of Information Technology"** means the New Mexico Department of Information Technology which is responsible for operating the data center and all communications related items.
- 29. **"Desirable"** the terms "may," "can," "should," "preferably," or "prefers" identify a desirable or discretionary item or factor (as opposed to "mandatory").
- 30. **"Determination"** means the written documentation of a decision of a procurement manager including findings of fact supporting a decision. A determination becomes part of the procurement file to which it pertains.
- 31. "DFA" means the Department of Finance and Administration for the State of New Mexico.
- 32. "**DFA/CRB**" means the Contracts Review Board of the Department of Finance and Administration for the State of New Mexico.

- 33. "ESSA" means the Every Student Succeeds Act, December 2015, is the nation's main education law for all public schools that holds schools accountable for how students learn and achieve. It replaces the No Child Left Behind Act.
- 34. **"Evaluation Committee"** means a body appointed by the Agency management to perform the evaluation of offeror proposals.
- 35. **"Evaluation Committee Report"** means a report prepared by the Procurement Manager and the Evaluation Committee for submission for contract award that contains all written determinations resulting from the conduct of a procurement requiring the evaluation of competitive sealed proposals.
- 36. **"Finalist"** is defined as an offeror who meets all the mandatory specifications of the Request for Proposal and whose score on evaluation factors is sufficiently high to qualify that offeror for further consideration by the Evaluation Committee.
- 37. "**Hourly Rate**" means the proposed fully loaded maximum hourly rates that include travel, per diem, fringe benefits and any overhead costs for contractor personnel, as well as subcontractor personnel if appropriate.
- 38. **"Mandatory"** The terms "must," "shall," "will," "is required," identify a mandatory item or factor (as opposed to "desirable"). Failure to meet a mandatory item or factor will result in the rejection of the offeror's proposal.
- 39. "**Minor Irregularities**" means anything in the proposal that does not affect the price, quality and/or quantity, or any other mandatory requirement.
- 40. "**Multiple Source Award**" means an award of an indefinite quantity contract for one or more similar services, items of tangible personal property or construction to more than one Offeror.
- 41. "**Needs assessment**" means a systematic process for determining and addressing needs or gaps between current conditions and desired conditions or wants.
- 42. **"New Mexico Employee"** means any resident of the State of New Mexico, performing the majority of their work within the State of New Mexico, for any employer regardless of the location of the employer's office or offices.
- 43. "**Nonprofit organization**" means an organization that is granted a tax-exempt status and is dedicated to furthering a particular social cause or advocating for a shared point of view.

- 44. "Offeror(s)" is any person, corporation, or partnership who chooses to submit a proposal.
- 45. "**Out-of-School-Time (OST)**" means the time spent engaged in educational activities beyond the traditional learning day as it applies to learning.
- 46. "PED" means the New Mexico Public Education Department.
- 47. **"Procurement Manager"** means the person or designee authorized by the Agency to manage or administer a procurement requiring the evaluation of competitive proposals.
- 48. "**Project**" means a temporary process undertaken to solve a well-defined goal or objective with clearly defined start and end times, a set of clearly defined tasks, and a budget. The project terminates once the project scope is achieved and project acceptance is given by the project executive sponsor.
- 49. "Quality Management Consultant (QMC)" means a person who works closely with an assigned group of grantees to provide technical assistance and coaching.
- 50. "**Redacted**" means a version/copy of the Offeror's proposal with the information considered proprietary or confidential (as defined by §§57-3A-1 to 57-3A-7, NMSA 1978 and NMAC 1.4.1.45 and summarized herein and outlined in Section II.C.8 of this RFP) blacked-out <u>BUT NOT</u> omitted or removed.
- 51. **"Request for Proposals"** or "RFP" means all documents, including those attached or incorporated by reference, used for soliciting proposals.
- 52. **"Requirements"** are obligatory and mean the system functions that are related to the organization's goals and business opportunities. Requirements are defined by the project team and are usually prioritized.
- 53. **"Responsive Offer or Responsive Proposal"** means an offer or proposal that conforms in all material respects to the requirements set forth in the request for proposals. Material respects of a request for proposals include, but are not limited to, price, quality, quantity or delivery requirements.
- 54. **"Responsible Offeror"** means an offeror who submits a responsive proposal and who has furnished, when required, information and data to prove that his financial resources production, or service facilities, personnel, service reputation, and experience are adequate to make satisfactory delivery of the services or items of tangible personal property described in the proposal.

- 55. "Site" means an individual community learning center.
- 56. "**Site-based leadership team**" means an interdisciplinary, school-based team that includes the school principal, teachers, the community school coordinator, and other school employees.
- 57. "**Site Coordinator**" means the employee responsible for overseeing the operations of one community learning center.
- 58. "Solicitations" means ITBs and RFPs.
- 59. "**Staff**" means any individual who is a full-time, part-time, or an independently contracted employee with the Offerors' company.
- 60. "State (the State)" means the State of New Mexico.
- 61. "**State Agency**" means any department, commission, council, board, committee, institution, legislative body, agency, government corporation, educational institution or official of the executive, legislative or judicial branch of the government of this state. "State agency" includes the Purchasing Division of the General Services Department and the State Purchasing Agent but does not include local public bodies.
- 62. **"State Purchasing Agent"** or "SPA" means the purchasing agent for the State of New Mexico or a designated representative.
- 63. "**Statement of Concurrence**" means an affirmative statement from the Offeror to the required specification agreeing to comply and concur with the stated requirement(s). This statement shall be included in Offerors proposal. (E.g. "We concur," "Understands and Complies," "Comply," "Will Comply if Applicable," etc.)
- 64. **"Targeted support and improvement (TSI)**" means a school identified as needing an intervention for a period of time under ESSA due to a consistently underperforming subgroup of students.
- 65. "**Teacher**" means a staff person employed by a district or charter school to provide instruction during the traditional learning day.

- 66. "**Team Member**" means any employee or volunteer of the State-Funded Out-of-School Time Program program.
- 67. "**Volunteer**" means any State-Funded Out-of-School Time Program team member who is not being paid for their time and has successfully completed a background check, allowing them to work with youth.
- 68. "USDE" means US Department of Education

## E. ELIGIBLE APPLICANTS

Eligible applicants include public or private organizations with documented and demonstrated ability to provide Services as described in this RFP.

# iii. GENERAL REQUIREMENTS

## A. ACCEPTANCE OF CONDITIONS GOVERNING THE PROCUREMENT

Potential Offerors must indicate their acceptance of the Conditions Governing the Procurement section in the electronic submission form. Submission of a proposal constitutes acceptance of the Evaluation Factors contained in *Section IV., G. Evaluation* of this RFP.

## B. INCURRING COST

Any cost incurred by the potential Offeror in preparation, transmittal, and/or presentation of any proposal or material submitted in response to this RFP shall be borne solely by the Offeror. Any cost incurred by the Offeror for set up and demonstration of the proposed equipment and/or system shall be borne solely by the Offeror.

# C. PRIME CONTRACTOR RESPONSIBILITY

Any contractual agreement that may result from this RFP shall specify that the prime contractor is solely responsible for fulfillment of all requirements of the contractual agreement with a state agency which may derive from this RFP. The state agency entering into a contractual agreement with a vendor will make payments to only the prime contractor.

## D. SUBCONTRACTORS/CONSENT

The use of subcontractors is allowed. The prime contractor shall be wholly responsible for the entire performance of the contractual agreement whether or not subcontractors are used. Additionally, the prime contractor must receive approval, in writing, from the Agency awarding any resultant contract, before any subcontractor is used during the term of this agreement.

## E. AMENDED PROPOSALS

An Offeror may submit an amended proposal before the deadline for receipt of proposals. Such amended proposals must be complete replacements for a previously submitted proposal and must be clearly identified as such in the transmittal letter. Region 9 Education Cooperative personnel will not merge, collate, or assemble proposal materials.

# F. OFFEROR'S RIGHTS TO WITHDRAW PROPOSAL

- 1) Offerors will be allowed to withdraw their proposals at any time prior to the deadline for receipt of proposals. The Offeror must submit a written withdrawal request electronically and signed by the Offeror's duly authorized representative.
- 2) The approval or denial of withdrawal requests received after the deadline for receipt of the proposals is governed by the applicable procurement regulations.

# G. PROPOSAL OFFER FIRM

Responses to this RFP, including proposal prices for services, will be considered firm for one hundred twenty (120) days after the due date for receipt of proposals or ninety (90) days after the due date for the receipt of a best and final offer, if the Offeror is invited or required to submit one.

# H. DISCLOSURE OF PROPOSAL CONTENTS

The contents of all submitted proposals will be kept confidential until the final award has been completed by the Agency. At that time, all proposals and documents pertaining to the proposals will be available for public inspection, *except* for proprietary or confidential material as follows:

# a. **Proprietary and Confidential information is restricted to**:

1. confidential financial information concerning the Offeror's organization; and

2. information that qualifies as a trade secret in accordance with the Uniform Trade Secrets Act, §§57-3A-1 through 57-3A-7, NMSA 1978.

b. If the offeror choses to redact Proprietary and Confidential information, an additional but separate redacted version of Offeror's proposal, as outlined and defined in this RFP shall be submitted, on or before the Proposal Submission date as indicated in the Sequence of Events. A redacted proposal, in accordance with state law, containing the blacked-out proprietary or confidential information, shall be used in order to facilitate eventual public inspection (IPRA) of the non-confidential version of Offeror's proposal.

**IMPORTANT**: The price of products offered or the cost of services proposed **SHALL NOT** be designated as proprietary or confidential information.

If a request is received for disclosure of proprietary or confidential materials, the Agency shall examine the request and make a written determination that specifies which portions of the proposal should be disclosed. The proposal shall be open to public inspection subject to any continuing prohibition on the disclosure of proprietary or confidential information.

# I. NO OBLIGATION

This RFP in no manner obligates Region 9 Education Cooperative to the use of any Offeror's services until a valid written contract is awarded and approved by appropriate authorities.

# J. TERMINATION OF RFP

This RFP may be canceled at any time and any and all proposals may be rejected in whole or in part when the agency determines such action to be in the best interest of Region 9 Education Cooperative.

# K. SUFFICIENT APPROPRIATION

Any contract awarded as a result of this RFP process may be terminated if sufficient appropriations or authorizations do not exist. Such terminations will be effected by sending written notice to the contractor.

The Agency's decision as to whether sufficient appropriations and authorizations are available will be accepted by the contractor as final.

# L. LEGAL REVIEW

Region 9 Education Cooperative requires that all Offerors agree to be bound by the General Requirements contained in this RFP. Any Offeror's concerns must be promptly submitted in writing to the attention of the Procurement Manager.

## M. GOVERNING LAW

This RFP and any agreement with an Offeror which may result from this procurement shall be governed by the laws of the State of New Mexico.

## N. BASIS FOR PROPOSAL

Only information supplied, in writing, by the Agency through the Procurement Manager or in this RFP should be used as the basis for the preparation of Offeror proposals.

# **O. CONTRACT TERMS AND CONDITIONS**

1. The contract may follow the format specified and contain the terms and conditions set forth in the Sample Contract Appendix E. However, the Agency reserves the right to negotiate provisions in addition to those contained in this RFP (Sample Contract) with any Offeror. The contents of this RFP, as revised and/or supplemented, and the successful Offeror's proposal will be incorporated into and become part of any resultant contract.

2. Exceptions from the contract terms and conditions as set forth in the RFP Sample Contract are discouraged. Such exceptions may cause a proposal to be rejected as non responsive when, in the sole judgment of the Agency (and its evaluation team), the proposal appears to be conditioned on the exception, or correction of what is deemed to be a deficiency, or an unacceptable exception is proposed which would require a substantial proposal rewrite to correct.

3. Should an Offeror object to any of the terms and conditions as set forth in the RFP Sample Contract (APPENDIX F) strongly enough to propose alternate terms and conditions in spite of the above, the Offeror must propose specific alternative language. The Agency may or may not accept the alternative language. General references to the Offeror's terms and conditions or attempts at complete substitutions of the Sample Contract are not acceptable to the Agency and will result in disqualification of the Offeror's proposal.

4. Offerors must provide a brief discussion of the purpose and impact, if any, of each proposed change followed by the specific proposed alternate wording.

5. If an Offeror fails to propose any alternate terms and conditions during the procurement process (the RFP process prior to selection as successful Offeror), proposed alternate terms and conditions may not be considered later during the negotiation process. Failure to propose alternate

terms and conditions during the procurement process (the RFP process prior to selection as successful Offeror) is considered an <u>explicit agreement</u> by the Offeror that the contractual terms and conditions contained herein are <u>accepted</u> by the Offeror.

6. The initial contract resulting from this RFP will be for a period of one years. The contract may be extended beyond the original contract period by one-year or multi-year renewal options for a maximum of three additional years, at the Agency's sole discretion and by mutual agreement. The contract term will not exceed a total of four (4) years.

# P. CONTRACT DEVIATIONS

Any additional terms and conditions, which may be the subject of negotiation (such terms and conditions having been proposed during the procurement process, that is, the RFP process prior to selection as successful Offeror), will be discussed only between and the Offeror selected and shall not be deemed an opportunity to amend the Offeror's proposal.

# Q. OFFEROR QUALIFICATIONS

The Evaluation Committee may make such investigations as necessary to determine the ability of the potential Offeror to adhere to the requirements specified within this RFP. The Evaluation Committee will reject the proposal of any potential Offeror who is not a Responsible Offeror or fails to submit a responsive offer as defined in NMSA 1978, § 13-1-83 and 13-1-85.

# *R. RIGHT TO WAIVE MINOR IRREGULARITIES*

The Evaluation Committee reserves the right to waive minor irregularities. The Evaluation Committee also reserves the right to waive mandatory requirements provided that all of the otherwise responsive proposals failed to meet the same mandatory requirements and the failure to do so does not otherwise materially affect the procurement. This right is at the sole discretion of the Evaluation Committee.

# S. CHANGE IN CONTRACTOR REPRESENTATIVES

The Agency reserves the right to require a change in contractor representatives if the assigned representative(s) is (are) not, in the opinion of the Agency, adequately meeting the needs of the Agency.

# T. NOTICE OF PENALTIES

The Procurement Code, NMSA 1978, § 13-1-28 through 13-1-199, imposes civil, misdemeanor and felony criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for bribes, gratuities and kickbacks.

# U. AGENCY RIGHTS

The Agency in agreement with the Evaluation Committee reserves the right to accept all or a portion of a potential Offeror's proposal.

## V. RIGHT TO PUBLISH

Throughout the duration of this procurement process and contract term, Offerors and contractors must secure from Region 9 Education Cooperative and or written approval prior to the release of any information that pertains to the potential work or activities covered by this procurement and/or agency contracts deriving from this procurement. Failure to adhere to this requirement may result in disqualification of the Offeror's proposal or removal from the contract.

## W. OWNERSHIP OF PROPOSALS

All documents submitted in response to the RFP shall become property of the Region 9 Education Cooperative.

# X. CONFIDENTIALITY

Any confidential information provided to, or developed by, the contractor in the performance of the contract resulting from this RFP shall be kept confidential and shall not be made available to any individual or organization by the contractor without the prior written approval of Region 9 Education Cooperative.

The Contractor(s) agrees to protect the confidentiality of all confidential information and not to publish or disclose such information to any third party without procuring the Agency's written permission.

# Y. ELECTRONIC MAIL ADDRESS REQUIRED

THIS AGREEMENT is made and entered into by and between the State of New Mexico, **REGION 9 EDUCATION COOPERATIVE (REC 9)**, hereinafter referred to as the "Agency," and **<CONTRACTOR NAME>** hereinafter referred to as the "Contractor," and is effective as of the date set forth below upon which it is executed by the REC 9 Executive Director.

#### IT IS AGREED BETWEEN THE PARTIES:

#### 1. Engagement of Contractor.

Agency agrees to engage Contractor on a non-exclusive basis to perform the services set forth herein, on a non-exclusive basis, to the Agency during the term of this Agreement in such amounts as the Agency shall require in its sole discretion. B Nothing contained in this Agreement shall require Agency to pay for any unsatisfactory work, as determined by Agency, or for work that is not in compliance with the terms of this Agreement. In no event will the Contractor be paid for services provided in excess of the total compensation amount without this Agreement being amended in writing prior to those services in excess of the total compensation amount being provided. Contractor is responsible for notifying the Agency no less than 30 days prior to the services provided under this Agreement reaching the total compensation amount.

C. Payment is subject to availability of funds pursuant to the Appropriations provisions set forth in Paragraph 6 below and to any negotiations between the parties from year to year pursuant to

Paragraph 2, Scope of Work. All invoices MUST BE received by the Agency **no later than 5:00 pm MST on XXX**. Invoices received after such date WILL NOT BE PAID.

D. Contractor shall submit monthly detailed invoices accounting for all services performed and expenses incurred. If the Agency finds that the invoiced services or expenses are not acceptable, within thirty days after the date of receipt of written notice from the Contractor that payment is requested, it shall provide the Contractor a letter of exception explaining the defect or objection to the services or expenses, and outlining steps the Contractor may take to provide remedial action. Upon certification by the Agency that the services or expenses have been received and accepted, payment shall be tendered to the Contractor within thirty days after the date of acceptance. If payment is made by mail, the payment shall be deemed tendered on the date it is postmarked. However, the agency shall not incur late charges, interest, or penalties for failure to make payment within the time specified herein.

# 4. <u>Term.</u>

THIS AGREEMENT SHALL NOT BECOME EFFECTIVE UNTIL SIGNED BY THE REC 9 EXECUTIVE DIRECTOR. This Agreement shall terminate on XXX unless terminated pursuant to paragraph 5 (Termination), or paragraph 6 (Appropriations).

# 5. <u>Termination.</u>

A. <u>Grounds</u>. The Agency may terminate this Agreement prior to the end of the term for convenience or cause, as set forth in Paragraphs 5.B.1 and 5.B.3. below The Contractor may terminate this Agreement as set forth in Paragraph 5.B.2 below.

# B. <u>Notice: Agency Opportunity to Cure.</u>

1. Except as otherwise provided in Paragraph 5.B.3., the Agency shall give Contractor written notice of termination at least thirty (30) days prior to the intended date of termination. Agency shall pay Contractor only for authorized Services performed up to the date of termination.

2. Contractor shall give Agency written notice termination at least sixty (60) days prior to the intended date of termination. Agency may agree, in writing, to waive such sixty (60) day notice requirement.

3. Notwithstanding the foregoing, this Agreement may be terminated immediately upon Agency's written notice to the Contractor if (i) the Contractor becomes unable to perform the services contracted for, as determined by the Agency; (ii) during the term of this Agreement, the Contractor is suspended or debarred by the State Purchasing Agent; or (iii) the Agreement is terminated pursuant to Paragraph 6, "Appropriations", of this Agreement.

C. <u>Liability.</u> Except as otherwise expressly allowed or provided under this Agreement, the Agency's sole liability upon termination shall be to pay for acceptable work performed prior to the Contractor's receipt or issuance of a notice of termination; <u>provided</u>, <u>however</u>, that a notice of termination shall not nullify or otherwise affect either party's liability for pre-termination defaults under or breaches of this Agreement. The Contractor shall submit an invoice for such work within thirty (30) days of receiving or sending the notice of termination. <u>THIS PROVISION IS NOT EXCLUSIVE AND DOES NOT WAIVE THE AGENCY'S OTHER LEGAL RIGHTS AND REMEDIES CAUSED BY THE CONTRACTOR'S DEFAULT/BREACH OF THIS AGREEMENT.</u>

D. <u>Termination Management</u>. Immediately upon receipt by either the Agency or the Contractor of notice of termination of this Agreement, the Contractor shall: 1) not incur any further obligations for salaries, services or any other expenditure of funds under this Agreement without written approval of the Agency; 2) comply with all directives issued by the Agency in the notice of termination as to the performance of work under this Agreement; and 3) take such action as the Agency shall direct for the protection, preservation, retention or transfer of all property titled to the Agency and records generated under this Agreement. Any non-expendable personal property or equipment provided to or purchased by the Contractor with contract funds shall become property of the Agency upon termination and shall be submitted to the agency as soon as practicable.

# 6. <u>Appropriations.</u>

The terms of this Agreement are contingent upon sufficient appropriations and authorization being made by the Legislature of New Mexico for the performance of this Agreement. If sufficient appropriations and authorization are not made by the Legislature, this Agreement shall terminate immediately upon written notice being given by the Agency to the Contractor. The Agency's decision as to whether sufficient appropriations are available shall be accepted by the Contractor and shall be final. If the Agency proposes an amendment to the Agreement to unilaterally reduce funding, the Contractor shall have the option to terminate the Agreement or to agree to the reduced funding, within thirty (30) days of receipt of the proposed amendment.

## 7. <u>Status of Contractor.</u>

The Contractor and its agents and employees are independent contractors performing professional services for the Agency and are not employees of the Agency. The Contractor and its agents and employees shall not accrue leave, retirement, insurance or any other benefits afforded to employees of the Agency as a result of this Agreement. The Contractor acknowledges that all sums received hereunder are reportable by the Contractor for tax purposes, including without limitation, self-employment and business income tax. The Contractor agrees not to purport to bind the Agency unless the Contractor has express written authority to do so, and then only within the strict limits of that authority.

#### 8. <u>Assignment.</u>

The Contractor shall not assign or transfer any interest in this Agreement or assign any claims for money due or to become due under this Agreement without the prior written approval of the Agency.

## 9. <u>Subcontracting.</u>

The Contractor shall not subcontract any portion of the services to be performed under this Agreement **without the prior written approval of the Agency**. No such subcontract shall relieve the primary Contractor from its obligations and liabilities under this Agreement, nor shall any subcontract obligate direct payment from the Agency. A copy of an approved subcontract shall be sent to the Agency within 15 days of final execution.

#### 10. <u>Release.</u>

Final payment of the amounts due under this Agreement shall operate as a release of the Agency, its officers and employees, and the State of New Mexico from all liabilities, claims and obligations whatsoever arising from or under this Agreement.

## 11. <u>Confidentiality.</u>

Any confidential information provided to or developed by the Contractor in the performance of this Agreement shall be kept confidential and shall not be made available to any individual or organization by the Contractor without the prior written approval of the Agency. Contractor further agrees to comply with all provisions of the Family Educational and Privacy Act (FERPA), 20 U.S.C. Sec. 1232 (g) and to hold Agency harmless from claims, complaints or causes of action arising from an alleged violation of FERPA.

## 12. <u>Compliance with Law and Policies</u>.

In the performance of this Agreement, Contractor shall abide by applicable laws of the State of New Mexico, the rules of the Public Education Department, and the policies and regulations of the Agency, as they may exist or be hereafter amended. Compliance shall include, but is not limited to:

## A. Inspection of Public Records Act (IPRA)

In perpetuity, the Contractor shall strive to ensure that all reasonable requests to inspect public records are promptly and efficiently granted in accordance with the Inspection of Public Records Act (IPRA), NMSA 14-2-1 - 14-2-12; including, but not limited to, IPRA requested received by the Agency.

## 13. <u>Product of Service -- Copyright.</u>

All materials developed or acquired by the Contractor under this Agreement shall become the property of the Agency and shall be delivered to the Agency no later than the termination date of this Agreement. Nothing developed or produced, in whole or in part, by the Contractor under this Agreement shall be the subject of an application for copyright or other claim of ownership by or on behalf of the Contractor. Contractor shall further not cite to materials, data, analyses or reports developed or acquired under this Agreement without written permission of the Agency Executive Director or the Executive Director's Designee. The Contractor agrees to prepare and execute any licenses or transfers of copyright necessary to vest ownership in the Agency of any materials developed or acquired by the Contractor under this Agreement.

## 14. <u>Amendment.</u>

A. This Agreement shall not be altered, changed or amended except by instrument in writing executed by the parties hereto and all other required signatories.

B. If the Agency proposes an amendment to the Agreement to unilaterally reduce funding due to budget or other considerations, the Contractor shall, within thirty (30) days of receipt of the proposed Amendment, have the option to terminate the Agreement, pursuant to the termination provisions as set forth in Article 4 herein, or to agree to the reduced funding.

## 15. Merger.

This Agreement incorporates all the Agreements, covenants and understandings between the parties hereto concerning the subject matter hereof, and all such covenants, Agreements and understandings have been merged into this written Agreement. No prior Agreement or understanding, oral or otherwise, of the parties or their agents shall be valid or enforceable unless embodied in this Agreement.

## 16. <u>Penalties for violation of law.</u>

The Procurement Code, NMSA 1978 §§ 13-1-28 through 13-1-199, imposes civil and criminal penalties for its violation. In addition, the New Mexico criminal statutes impose felony penalties for illegal bribes, gratuities and kickbacks.

## 17. <u>Applicable Law.</u>

The laws of the State of New Mexico shall govern this Agreement, without giving effect to its choice of law provisions. Jurisdiction and venue shall be proper only in a New Mexico court of competent jurisdiction in accordance with NMSA 1978, § 38-3-1 (G). By execution of this Agreement, Contractor acknowledges and agrees to the jurisdiction of the courts of the State of New Mexico over any and all lawsuits arising under or out of any term of this Agreement.

## 18. <u>Records and Financial Audit.</u>

A. The Contractor shall maintain detailed time and expenditure records that indicate the date; time, nature and cost of services rendered during the Agreement's term and effect and retain them for a period of three (3) years from the date of final payment under this Agreement. The records shall be subject to inspection by the Agency and the State Auditor. The Agency shall have the right to audit billings both before and after payment. Payment under this Agreement shall not foreclose the right of the Agency to recover excessive or illegal payments.

B. Contractor shall provide background checks for any employees or sub-contractors that may have contact with children.

## 19. <u>Indemnification.</u>

The Contractor shall defend, indemnify and hold harmless the Agency and the State of New Mexico from all actions, proceeding, claims, demands, costs, damages, attorneys' fees and all other liabilities and expenses of any kind from any source which may arise out of the performance of this Agreement, caused by the negligent act or failure to act of the Contractor, its officers, employees, servants, subcontractors or agents, or if caused by the actions of any client of the Contractor resulting in injury or damage to persons or property during the time when the Contractor or any officer, agent, employee, servant or subcontractor thereof has or is performing services pursuant to this Agreement. In the event that any action, suit or proceeding related to the services performed by the Contractor, the Contractor, the Contractor shall, as soon as practicable but no later than two (2) days after it receives notice thereof, notify the Agency by certified mail.

## 20. Invalid Term or Condition.

If any term or condition of this Agreement shall be held invalid or unenforceable, the remainder of this Agreement shall not be affected and shall be valid and enforceable.

# 21. Enforcement of Agreement.

A party's failure to require strict performance of any provision of this Agreement shall not waive or diminish that party's right thereafter to demand strict compliance with that or any other provision. No waiver by a party of any of its rights under this Agreement shall be effective unless express and in writing, and no effective waiver by a party of any of its rights shall be effective to waive any other rights.

#### 22. <u>Notices.</u>

Notice by either party shall be in writing and shall be delivered by courier service, or U.S. mail, or by electronic mail to the receiving party designee as specified below. Electronic notification shall be deemed received at the time the party sending electronic notice receives written verification of receipt by the receiving party, including but not limited, to a read receipt.


